Evaluating baseline support metrics via EMA-100 indicates an expanding consolidation envelope, keeping near-term price swings within defined statistical thresholds.

Advanced MACD signal configurations trace a definitive Bearish Divergence, hinting at impending implied volatility shifts over a 17-day cycle.

With normalized EPS tracking steadily at \$14, our valuation models suggest that the company's revenue growth rate of -3.5% is fundamentally supported by robust, high-quality asset turnover cycles.

Free cash flow conversion tracks near 80%, granting stable runway for capital returns and securing a competitive 65th position in peers assessment.

From a fundamental stock analysis perspective, \$1 in nepali rupees fields a P/E ratio of 16.93x, showcasing a resilient -3.5% revenue growth scale within the Quantum Computing Systems landscape.

Operating margins inside the Quantum Computing Systems field remain heavily anchored to the efficiency of internal operational structures, where \$1 in nepali rupees displays a

unique ability to accelerate compounding expansion.

SENTIMENT FLOW & MICROSTRUCTURE

Options market architecture reveals an asymmetric skew toward put positioning at the \$258.33 strike array.

A short interest layout of 7.7% coupled with institutional control metrics reaching 67% creates a framework where any positive sentiment catalyst could quickly trigger an automated short squeeze.
