loading up on put blocks near the \$4631.4 strike, setting up an asymmetric risk profile.

A short interest layout of 12.4% coupled with institutional control metrics reaching 69% creates a framework where any positive sentiment catalyst could quickly trigger an automated short squeeze.

Analysis of order book thickness reveals that institutional blocks are quietly building deep support beds, lowering the risk of sudden liquidity shocks before the upcoming earnings date on Jul 05.

Options market architecture reveals an asymmetric skew toward call positioning at the \$4731 strike array.
